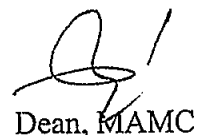

The aforesaid permission to the conduct of the festival is conveyed on the following terms and conditions:-

1. All the students and associated persons will keep the sanctity of the College at the highest level.
2. Strict time keeping of all the functions will be maintained. All the functions will stop at 10.00pm .
3. During office hours, no loud speakers or drum or other loud musical instruments will be used in open so that college functions normally without disturbance.
4. Entrances to the college and its premises will not be blocked at all.
5. Alcohol, smoking or psychotropic drugs of any type will not be allowed to be used in the premises of the College. If any person is caught during the function consuming any of the above mentioned material, executive committee members of the AMA will be held responsible for the act apart from the person caught.
6. Campus will be kept clean keeping the spirit of Swatchh Bharat Abhiyan. None of the lawn and plants are to be damaged.
7. No individual and group on the basis of caste, creed and religion will be targeted during the event.
8. Any activity which does not have the support of the Faculty shall not be allowed.
9. College Logo will not be utilized any where without the prior permission of the Faculty.
10. No controversial/ objectional matter will be displayed either on board or through visual form, spoken, acted upon.
11. AMA executive members will be responsible for the security arrangements for all the events of the festival.

The AMA will submit the duly verified bills in respect of the expenses made to the Synapse Committee within a weeks time of the completion of the event.
