- (iv) That the information regarding No. of participants category wise (UGs, PGs, Interns, Medical Officers, Specialists, para medical staff, Nursing staff) who will be benefitted in respect of each proposed Training/Workshop in current F.Y. 2024-25 and similarly actual no. of trainees/participants category wise who attended the training programme for each training/workshop be provided by the concerned faculty members.
- (v) Expenditure shall not exceed the sanction amount.
- (vi) Expenditure shall be made spent within the limit as prescribed under Delegation of Financial Power issued by Govt. of NCT of Delhi vide OM dated 07.08.2019.
- (vii) If training workshop incharge, collect/charge any fee/amount from participants or for any services, rate should be approved by competent authority. It should be deposited in Govt. Receipts and should not adjusted against expenditure.
