Sir/Madam.

The proposal should be strictly in accordance with the enclosed guidelines issued vide letter dated 12.04.2023, and as per the enclosed Check-list (Annexure-I) and Undertaking (Annexure-II). Any proposal which is not in accordance with the guidelines and check-list will not be considered.

In this regard, it is stated that this office had requested all the departments vide letter dated 01.02.2024 to submit their proposal if any, latest by 10.02.2024 so that a consolidated proposal of the college could be sent in time for obtaining the necessary Administrative Approval and Expenditure Sanction of Planning /Finance Department. But till date only three Departments have given proposals for conducting Training/Workshops.

You are once again requested to kindly send the proposal of your department to Planning Branch latest by 02.03.2024 according to Guidelines issued vide letter dated 12.04.2023 and complete as per Annexure I & II (The detailed information is also available on the official website i.e <MAMC><Administration><Planning Branch><Circular/Notices>).
