Candidates should attend the interview on their own expenses at the Department of Microbiology, Maulana Azad Medical College, New Delhi.

  applications received, a list of eligible shortlisted candidates will be displayed on
  MAMC website. If necessary, a written examination will be conducted and the
  candidates qualifying the written test will only be interviewed. No TA/DA will be
  paid for attending the interview/skill assessment.
- 2. Mere fulfilment of the essential qualification/experience does not guarantee selection. The decision of the selection committee regarding appointment of candidates will be final and no representation will be entertained in this regard. Selection committee reserves all rights to change the selection procedure, rules & cancellation of rules.
- 3. Applications not submitted in prescribed format and applications without supportive documents shall be summarily rejected.

Experience shall be counted from the date of completion of minimum essential educational qualification.
