- (1) The post is temporary and he/she will be appointed on officiating basis only on tenure of 03 years including any service rendered as Senior Resident earlier on ad-hoc/regular basis in any Institution anywhere in India.
- (2) The appointment can be terminated at any time by giving one month's notice by either side viz the appointee or the appointing authority without assigning any reason. The appointing authority however reserves the right of terminating the services forthwith on or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the notice period.
- (3) **The present appointment is for a period of one year, which is extendable upto 03 years on an annual basis, subject to the satisfactory work and conduct report from concerned Head of Department and subject to the condition mentioned in circular No. F.No. 121/26/2010/H&FW/1996-2045 dated 10.06.2011 issued by H&FW Department, Govt. of NCT of Delhi.**
- (4) **Private practice of any kind, whatsoever, is strictly prohibited.**



The appointment is further subject to:-

- a). Production of Proof of Age, Registration Certificate from D.M.C., Educational and other certificate (in original) alongwith attested photocopies of each certificate and caste certificate of SC/ST/OBC category (for reserved category).
- b). A favorable character antecedent verification report from concerned competent authority, where candidate has been residing during last five years.
- c). An undertaking to the effect that he/she has not done the Senior Residency for a period of three years, prior to this appointment.
- d). Production of Medical fitness from Appropriate Authority.

In case the concerned Doctor is under service or under obligation to serve, any Centre/State Government's Department or Public Sector Authority, a 'Discharge Certificate' from the previous employer is required.

In case the offer of appointment is acceptable on the terms and conditions, he/she should submit his/her consent to the undersigned within **10 days** from the date of issue of this offer alongwith the declaration regarding the marital status, an oath of allegiance/faithfulness to the Constitution of India. If no reply is received within 10 days from the date of issue of this Memorandum, it will be presumed that he/she is not interested in the offer of appointment and the same will be treated as cancelled automatically without giving any notice. If any declaration given by the candidate proves to be false or found to have willfully suppressed any material fact, he/she will be liable for removal from service or any other action as may be deemed fit.
