NOTICE

The process of recruitment for the post of Senior Resident on regular basis in various Hospitals/Medical Institutions of Govt of Delhi was initiated by this office vide Notice dated 29-10-2025. The result and postings were declared vide Notice dated 5-1-2026. Some vacancies remain unfilled due to non-joining of the selected candidates.

This office issued a Notice vide reference No.F.50 (Rectt)/SR/2025/MC/E-II/4466 dated 4-4-2026 asking candidates who had accepted the offer of appointment and joined the assigned Hospital/Medical Institution and now wish to seek upgradation/change of posting, to fill and submit Google Form by 10-4-2026 to be considered for the Counseling process.

In this regard it is informed that the above Counselling process will be held on Thursday, 16th April 2026 at 9:30 AM at the office of Dean, Maulana Azad Medical College, 2, Bahadur Shah Zafar Marg, New Delhi-110002. The following are the terms and conditions of the above Counselling process:-

- 1) Only those candidates who fulfill the criteria and have filled the Google Form using the Link given in Notice dated 4-4-2026 by the last date of submission are eligible to appear in the above Counselling process.
- 2) The candidates who have not accepted/joined the offer of appointment are strictly not eligible to participate in counseling process.
- 3) Submission of the online form shall not confer any right or guarantee for upgradation/change of posting. Upgradation shall be considered strictly on the basis of merit list of the interviews held in December 2025, preference exercised by the candidate in google form, availability of vacancy, and applicable rules and guidelines.
- 4) Candidates must appear physically on the above date and time and must bring the following on the day of counseling:-



- a) Printed copy of the online google form submitted with reference to Notice dated 4-4-2026.
 - b) Taken on strength order issued by the Hospital/Medical Institution where they have joined in pursuance of result dated 5-1-2026.
 - c) No-Objection-Certificate to appear in the counseling process issued by the Head of their respective Institution/Hospital, where they have joined.
- 5) This shall be the final round of counselling for upgradation, and no further request for change of posting shall be entertained thereafter.
 - 6) The decision of the Chairperson of the Centralized Recruitment Committee shall be the final in case of any disagreement among the candidates during the counseling process.
 - 7) The process of offer of appointment to the candidates in the panel of the result dated 05.01.2026 shall be initiated after the completion of the above counseling process & resulting joining of candidates.
