
SUB.: DR. RAJENDRA PRAKASH MATHUR MEMORIAL MEDAL - 2022

The Dean, MAMC has constituted a Committee consisting of 5 members i.e. Dr. G.K. Ingle, Dr. P.N. Agarwal, Dr. Neelam Vasudeva, Dr. M.K. Daga and Dr. S.K. Gupta to review/formulate the guidelines of existing awards/medals (as per list attached) (S/c). As per list 14 awards were listed for the purpose of review (N/I), rest of the awards are based on University remarks and internal assessment, so, according to Registrar(Academic) no revision or formulation of guidelines is required in those cases (N/I). The Chairman of the Committee has convened meetings 7 times however, meetings could be held only thrice and rest of the times the meeting was cancelled or postponed due to various reasons mentioned in the correspondence pages of the file. In all 3 meetings, only Dr. S.K. Gupta and Dr. Neelam Vasudeva were present and remaining 2 members never attended any meeting.

Regarding S.No. 1. Dr. Samir Marwah Memorial Award - on perusal of the file it was detected that the award was instituted and was earlier given to the Unit for best presentation in clinical meetings. However, subsequently, the award was not given on number of occasions as no clinical presentations were held during those years. Since year 2004, this award was given to the best T.T. player and since then, it is awarded to the best T.T. Player. This is a major discrepancy and it needs to be resolved. The Committee recommends that the award should be given as per original guideline and to rectify the mistake. As the award is given during last decade to best T.T. player, it is suggested that a Certificate for best T.T. player should be given in place of this award and the Certificate should be titled as "Best Table Tennis player of MAMC for the year...."

Sr. No. 2. Vidya Ratan Schgal M.D. Award - No need to review. The guideline is clear.

Sr. No. 3. K.B. Sharma Rolling Trophy - as per existing guideline the trophy is rewarded to the student who is contributing to the corporate life of the college. The committee feels that the criteria seem to be vague and needs objectivity and hence, it suggests the following criteria for award of this trophy from the year 2017 onwards

A) There should not be any adverse report in any manner against the student applying for this trophy.

B) He should qualify final MBBS Part-II

C) Since first MBBS exam till final MBBS Part-II, he should qualify all the examinations in first attempt. However, one supplementary with bonafide reasons may be permitted

D) He should contribute in the following areas with max marks suggested against the criteria :

Sr. No. 4 Dr. V.N. Sehgal Medal - No need to revise the criteria.

Sr. No. 5 Dr. Manoj Kapoor Memorial Medal - the award is given to best PG student in Pediatrics. Comments - earlier marks were not awarded in the professional examination during Post Graduation. However, now marks are introduced, hence the criteria should be : a) students are having higher marks b) should pass in first attempt c) Overall best performance during 3 years of residency d) if marks are not awarded, it is suggested that the HOD pediatrics should request the board of examiner for ranking the examinee so that the award can be decided on merit.

Sr. no. 6 R.P. Mathur Memorial Award - as per criteria, the best PG student to be decided by the committee comprising of Dean, HOD (Pathology), Senior-most Sr. Resident, it is suggested that it should be followed.

Sr. No. 7 Dr. Sudhir Rehan Memorial Award - comments - it is suggested that letter should be sent with the guideline to the HOD (Medicine) for compliance of guideline in awarding the Medal. As far as possible the award should not shared and should be given to best 3rd yr outgoing PG student in Medicine.

Sr. 8 Dharamveer Gold Medal - No original guideline available - however, the criteria followed seems to be satisfactory

Sr. No. 9 Lt. Governor Rolling Trophy - Criteria satisfactory. No need to change.

Sr. no 10 Flemmings Trophy- comments - initially the list of subjects was not complete, however, subsequently, remaining departments were added. Criteria refined in 2013 and seems to be satisfactory.

Sr. No. 11 Alumnus Award - No original guideline available - however, the criteria followed seems to be satisfactory

Sr. No. 12 Pyare Lal Sharma Bishan Devi Award - for pre and para clinical subjects - the criteria follows seems to be satisfactory. the HOD (Community medicine) has repeatedly requested that as per MCI, CM is a clinical subject and hence, it should be excluded from this award

Sr. No. 13 Pyare Lal Sharma Bishan Devi Award - for best thesis in clinical subjects - the HOD (Community medicine) has repeatedly requested that as per MCI, CM is a



Other comments /suggestions - Micro filing of all the files should be done . CD should be available in the Academic section and also with Academic Officer


The Academic sections should make the criteria of particular Award available to the concerned committee.
