**ADDENDUM/CORRIGENDUM**

In continuation of "Declaration of Result" vide ref. no. F-22(04)/SR/2025/MC/E-II/251 dated 05.01.2026 regarding recruitment of Senior Resident on regular basis in various hospitals/Institutional Institutes of Govt. of NCT of Delhi, the following addition/amendments have been made:-

1. In Orthopedics department result, the category of Dr. Kiran Rani at S.no. 58 may be read as "ST" instead of "SC". The place of posting remains the same.
2. In Pathology department result, the name of candidate at S.no. 26 may be read as "Maj (Dr.) Bhavna Verma (Retd.)" instead of "Maj. (Dr.) Bhawana Verma (Retd.)".
3. In Pathology department result, the name of candidate at S.no. 28 may be read as "Dr. Surabhi Chaudhary" instead of "Dr. Surabhi".
4. In Obst. & Gynae result, the name of candidate at S.no 11 may be read as "Dr. Harshi Bansal" instead of "Dr. Hassni Bansal".
5. In Community Medicine result, the name of candidate at S.no 2 may be read as "Dr. Ajanya . V" instead of "Dr. Anjanya V".
