NOTICE

The Committee for Centralized recruitment of Senior Residents for various hospitals/institutions under Health & Family Welfare, GNCT of Delhi was constituted by the Health Department with the approval of the competent authority vide order no. F.11/79/H&FW/HR-MED/2023#112745287/1743-49 dated 12.09.2024 and Dean, MAMC was nominated as the Chairperson of the committee.

The process of recruitment was started in October 2025 and applications were invited from the candidates for interview. As per point no. 8 of Terms and Conditions of Notice dated 24.10.2025 the validity of the panel will be for six months from the date of declaration of result. The interviews were conducted in the MAMC and its associated hospitals in December 2025. The result of selected Senior residents along with waiting panel was declared on 05.01.2026 and was published on the website of MAMC as per the vacancy roster.

Then the result of upgradation of posting of Candidates was declared on 17.04.2026. The waiting panel was activated and the candidates in the panel were posted in the hospitals vide notice dated 05.05.2026, 04.07.2026 and its addendum dtd 09.07.2026. The waiting panel of all specialities except Ophthalmology were closed on last date of validity of panel i.e 04.07.2026.

However, as per the directions of Hon'ble CAT in O.A no. 2245/2026 title Arun Mehta Vs Govt. of NCT of Delhi the validity of waiting panel of Ophthalmology was kept operative beyond its normal validity solely for the purpose of compliance with the directions of the Hon'ble CAT.

Since the prescribed validity period of the waitlisted panel, as stipulated in the Recruitment Notice dated 24.10.2025 has elapsed, the recruitment for the appointment of Senior Residents on a regular basis in various hospitals/medical institutions under the Govt. of NCT of Delhi is hereby declared closed. Consequently, the waitlisted panel of all specialities shall cease to have any further validity or operative effect.
