Applications are invited from eligible candidate to be appointed to work on purely temporary contractual basis for a period of 08 months in **State Level Viral Research & Diagnostic Laboratory (VRDL)**, Department of Microbiology, Maulana Azad Medical College, New Delhi. Willing eligible candidates may attend the walk-in-interview on the below mentioned date at 10.30A.M at the office of the undersigned. Candidates reporting after 10.00 A.M shall not be entertained. Terms and Conditions:-

For the above post candidate should not have completed the age as mentioned in table. Age limits shall be reckoned as on the closing date of receipt of applications.

1. The candidates should bring all original certificates of educational qualifications, Experience, Aadhaar Card, along with one set of photocopies of the same duly self-attested and 2 passport size photographs.
2. No TA/DA shall be paid for attending the interview.
3. Mere fulfilment of the essential qualifications/experience does not guarantee selection. The decision of the selection committee regarding appointment of the candidate will be final and no representation will be entertained in this regard. Selection committee reserves all rights to change the selection procedure, rules & cancellation of rules.
4. In case large number of applications are received from the potential candidates, screening the candidates through written test may be held for the given post. Only shortlisted candidates by the committee shall be interviewed.

5. The above post is purely temporary and are initially for 08 months. This could be extended/terminated depending as per the requirement of the Scheme and satisfactory performance of the staff.
6. Qualification and experience should be in a relevant discipline/field and from a reputed institution/organization by relevant authority. Experience shall be counted from the date of completion of minimum essential educational qualification. Age limit and experience will be considered as on the date of walk-in interview/personal discussion/skill assessment.
7. Submitting of incorrect or false information during the process of walk-in interview/or personal discussion shall disqualify the candidature at any stage.
8. Canvassing and bringing inside or outside influence in any form for short listing and employment will be treated as a disqualification and the candidate will be debarred from selection process.
9. The post is contractual for 08 months. No benefit of provident fund, Leave travel concession, Medical claim etc. Will be considered, since the post is purely on contract basis. The appointment may be renewed after every specific period of time, subject to budget grant from the funding agency, satisfactory performance and project requirement.
10. The candidate will have no right to claim for any type of permanent employment under MAMC or Delhi Government or continuation of his/her services in any other project.
11. Recruited candidate will be notified on website (www.mamc.ac.in).
12. Candidate who will report after the scheduled date/time will not be allowed to appear in an interview/or personal discussion.
13. Appointment will be given as per rules and regulation of the competent authority. Any addendum/corrigendum in respect of above vacancy, notice shall be issued in the press.
14. The advertised post is under the scheme for control of outbreaks and epidemics and hence the candidate may have to work in the affected areas in the country as and when required during an epidemic.
15. The competent authority review the work of candidates appointed on the contract basis. If the review is unsatisfactory, the competent authority reserves the right to terminate the appointment of the candidate without any prior notice.
16. Covid 19 appropriate behaviour need to be followed during the interview session.
