#### A. Essential Educational Qualifications .

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-Graduate degree in the concerned speciality or super-speciality mentioned in Section- A of Schedule VI from recognized Teaching Institute.

#### **B. EXPERIENCE:**

At least three years teaching experience as Senior Resident or tutor or Demonstrator or Registrar or Assistant Professor or Lecturer in the concerned specialty or Super Specialty in a recognized teaching institution after obtaining the first Post Graduate degree.

**NOTE:- I:** Doctorate of Medicine (D.M.) or Magistar chirurgiae (M.ch) qualification of three years duration shall be counted towards requirement of teaching experience.

**Note:- II:** Doctorate of Medicine (D.M.) or Magistar chirurgiae (M.ch) of five years' duration shall be taken as three years for completion of post graduate degree and last two years of the said Doctorate of Medicine (D.M.) or Magistar chirurgiae (M.ch) shall be counted towards requirement of teaching experience.

NOTE:- III: For recruitment to the post of Assistant Professors (Immuno-haematology and Blood Transfusion), D.M. (Immunology) or M.D. (Immuno-Haematolgoy& Blood Transfusion or MD (Pathology/ Bacteriology/Haematology) with at least three years's experience in a recognised teaching hospital in Immmuno-haematolgoy and Blood Transfusion (Blood Banks) or in Pathology/ Bacteriology/Haematology with two years experience or special training in Immuno-haematology and Blood Transfusion (Blood Bank) as a Lecturer or Tutor or Senior Resident or Demonstrator after the Post Graduate Qualification in the speciality.

**NOTE:- IV:** Teaching experience in any other post like the post of General Duty Medical Officer or Medical Officer shall not be considered for eligibility purpose for recruitment to teaching post.

Age:- Not exceeding 40 Years as on date of Notification.

#### TERMS AND CONDITIONS OF CONTRACTUAL APPOINTMENT

- The appointment is purely on contract basis for a period of one year (extendable up to 02 years) or till the regular incumbent joins or till further orders, whichever is earlier with effect from the date of joining. Thereafter, the contract will lapse automatically. The appointment can also be terminated at any time on either side by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three month's to the satisfaction of the competent authority.
- II. The consolidated remuneration will be Rs. 95000/- per months.
- III. The appointee shall perform the duties assigned to him/her. The Competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.

- IV. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants appointed on regular basis.
- V. Non-practicing Allowance will not be admissible.
- VI. The appointee will not be granted any claim or right for regular appointment to any post under Central Health Service.
- VII. The appointee shall be on the whole time appointment of the Institution and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
- VIII. The appointment to the said post will be subject to physical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority by the concerned Institution/ Hospital before joining the post.
- IX. The appointee is required to submit a declaration regarding his/her marital status in the enclosed proforma.
- X. The leave entitlement of the appointee shall be governed in terms of instructions contained in DOPT OM No. 12016/3/84-Estt.(L), dated the 12, April, 1985, as amended by OM No. 12016/1/96-Estt. (L) dated the 5<sup>th</sup> July, 1990.
- XI. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that affect in the prescribed proforma.
- XII. The appointee is not entitled to any TA for joining the appointment.
- XIII. Other conditions of service will be governed by relevant rules and orders issued from time to time.
- XIV. If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any material information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
