**Notice for Engagement of Assistant Professors and Non-Teaching Specialists
Grade-III on contractual basis.**

The Centralised Committee constituted by the Health & Family Welfare Department, Govt of NCT of Delhi will conduct Walk-in-Interviews for engagement of Assistant Professors and Non-Teaching Specialists Grade-III, both on contractual basis for various Specialities /Departments of different Hospitals/Medical Institutions under Govt of NCT of Delhi. There will be a common interview for these two posts. The candidates will be selected for either of the two posts taking into consideration their eligibility, performance in interview, preference of post and other relevant parameters.

The Walk-in-Interviews will be held at Maulana Azad Medical College (MAMC), 2, Bahadur Shah Zafar Marg, New Delhi-110002 and its associated hospitals namely Lok Nayak Hospital (LNH), Jawahar Lal Nehru Marg, New Delhi-110002, Govind Ballabh Pant Institute of Post-Graduate Medical Education and Research (GIPMER), Jawahar Lal Nehru Marg, New Delhi-110002 and Guru Nanak Eye Centre Maharaja Ranjeet Singh Marg New Delhi-110002.

The following is the Detailed Information:--

1) SUBMISSION OF FORM

Eligible candidates are requested to fill and submit the Google Form using the link [\(CLICK HERE\)](#) by 8th February 2026 (11:59 PM). Only those candidates who fill this Google Form by the due date will be eligible to appear for the Walk-in-Interview. The above link will be disabled after the above deadline.

2) INTERVIEW SCHEDULE

The interviews will start in the third week of February 2026. The schedule of the interview will be uploaded on the website of MAMC after 8th February 2026.

3) DETAILS OF POSTS

a) **Assistant Professors**:-

The details of number of vacant posts category wise in different specialities of various hospitals/medical institutions is given at Annexure-I & II

b) **Non-Teaching Specialists**:-

The details of number of vacant posts category wise in different specialities of various hospitals/medical institutions is given at Annexure-III & IV

4) ESSENTIAL EDUCATIONAL QUALIFICATION:-

(a) For both Assistant Professors and Non-Teaching Specialists :-

- i) A recognized MBBS/BDS Degree qualification included in the First Schedule or Second Schedule or Part II of the third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualification included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- ii) Post graduate degree or diploma in the concerned speciality or super-speciality mentioned in Section-A or Section-B in Schedule-VI from recognized Teaching Institute.

5) ESSENTIAL EXPERIENCE:-

For Assistant Professors:-

At least three years teaching experience as Senior Resident or tutor or Demonstrator or Registrar or Assistant Professor or Lecturer in the concerned Speciality or Super Speciality in a recognized teaching institution after obtaining the first Post Graduate degree.

NOTE: I

Doctorate of Medicine (DM) or Master of Chirurgiae (M.ch) qualification of three years duration shall be counted towards requirement of teaching experience.

Note:II

Doctorate of Medicine (D.M.) or Master of Chirurgiae (M.ch) of five years duration shall be taken as three years for completion of post graduate degree and last two years of the said Doctorate of Medicine (DM) or Master of Chirurgiae (M.ch) shall be counted towards requirement of teaching experience.

NOTE:III

For the post of Assistant Professor required eligibility and qualification will be as per National Medical Commission Gazette Notification No. N-P051(12)/18/2024-PGMEB-NMC dated 30th June 2025.

NOTE:IV

Teaching experience in any other post like the post of General Duty Medical Officer or Medical Officer shall not be considered for eligibility purpose for recruitment to teaching post.

For Non-Teaching Specialists:-

Three years experience in the concerned Specialty /Superspeciality after obtaining the first Post-Graduate Degree or five years experience after obtaining the Post-Graduate Diploma in the concerned Specialty.

6) AGE LIMIT

For both Assistant Professors and Non-Teaching Specialists :-

Maximum age for eligibility is not exceeding 40 years as on the date of interview. Age relaxation will be as per extant rule for candidates belonging to reserved category (SC/ST/OBC/PwD/EWS).

7) REMUNERATION

a) For Assistant Professors:-

Consolidated Remuneration shall be **Rs. 1,23,500/- (for first year of contract)** and **Rs. 1,30,000/- (for second year onwards)**.

b) For Non-Teaching Specialists:-

Consolidated Remuneration shall be as per Level-11 of 7thCPC (basic pay + other applicable allowances)

8) DOCUMENTS REQUIRED - (at the time of interview)

For both Assistant Professors and Non-Teaching Specialists:-

- b) Copy of Certificate/Mark Sheet of Matriculation/Class X
- c) Copy of Certificate/Mark Sheet of Senior Secondary/Class XII
- d) Copy of Degree/Certificate/Marksheet of MBBS/BDS Degree
- e) Copy of Internship Completion Certificate
- f) Copy of Degree/Certificate/Marksheet of MD/MS/MDS/PG Degree/Diploma
- g) Experience Certificates
- h) Copy of DMC registration certificate or copy of acknowledgement slip
- i) Copy of Caste Certificate (SC/ST/OBC/)
- j) Copy of OBC Certificate along with Non-Creamy Layer Certificate valid for financial year 2025–2026 issued by Govt. of NCT of Delhi
- k) Copy of EWS Certificate valid for financial year 2025–2026 issued by Govt. of NCT of Delhi
- l) Copy of appropriate Certificate for candidates belonging to PwD category.
- m) A Proof Identity issued by a Govt Authority like Aadhar, PAN, Passport etc.
- n) Two passport size color photographs
- o) Any other document (if applicable)

9) FEE

A Fee of Rs. 1000/- will be charged from the UR, OBC & EWS applicants in the form of ‘Demand Draft’, issued in favour of “PAO-XV” payable at New Delhi (Non-refundable). The SC/ST/PwD applicants are exempted from payment of fee.

10) GENERAL TERMS AND CONDITIONS

(For Both Assistant Professors & Non-Teaching Specialists)

- i. The candidate will appear for the interview on the scheduled date to be announced later on website of MAMC. No request for change of date will be entertained.
- ii. The candidates are requested to bring all original documents alongwith one set of self attested Xerox copy of their documents from class Xth onwards.
- iii. SC/ST certificates issued only from Competent Judicial/Revenue authorities shall be accepted.

- iv. OBC Category Candidates are required to submit their Caste Certificate along with Non-Creamy Layer (NCL) Certificate, issued after 31.03.2025 by Govt. of NCT of Delhi in r/o the “Community” they belong to, which is recognized as Other Backward Class under the Government of NCT of Delhi Notification no. F.28(93)/91-92/SCST/P&S/4388 dated 1995-01-20, published in the Gazette of Delhi Extraordinary Part-IV.EWS certificate valid for financial year 2025-2026 shall only be accepted.
- v. In case of EWS the engagement is provisional and is subject to the Income and Asset Certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
- vi. Candidates should have valid DMC/Dental Council Registration Certificate.
- vii. No TA/DA will be paid for appearing in the interview.
- viii. The appointed candidate will not be entitled to any kind of accommodation and other concessionary allowance.
- ix. Appointee/employee to the post will not be entitled to claim permanent position/regularization of services in any condition.
- x. Agreement in the Standard Prescribed Format shall be signed and executed between the contractual appointee and the MS/MD of concerned hospital.
- xi. The selected appointee on contractual basis shall submit two original sets of signed contractual agreement within seven days of the declaration of result.
- xii. Any letter of resignation submitted by the contractual employee will be treated as a letter communicating the intention of the contractual employee to terminate the contract. If a contractual employee wishes to terminate the contract by giving 30 (thirty) days notice, it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No notice is required, if service is terminated on disciplinary grounds/falsification of declared information/joining of regular incumbent.
- xiii. The Tenure of contractual appointment will be for a period of one year or till a regular incumbent joins whichever is earlier. The contractual appointment will be terminated on joining of a regular incumbent at any time.
- xiv. The above posts shall be filled on regular basis through UPSC and the contractual doctors will have no claim on regular recruitment solely because of contractual engagement served at the concerned hospital
- xv. Private Practice of any kind is not allowed.
- xvi. Contractual employees are governed only by the terms and conditions mentioned in the contract agreement and are not entitled for any other allowances, financial benefits or concessions of medical facilities, grant of LTC benefits, GPF, Pension Benefits, DGEHS, Provisions of FR/SR etc., that are applicable to only regularly appointed doctors of Government of NCT of Delhi.
- xvii. The timings of work/duties/responsibilities of contractual engagement would generally be same as those of regular appointed specialists.

- xviii. Engagement/Appointment shall be subject to Medical Fitness and Verification of Certificates/documents/Police Verification.
- xix. Any canvassing by or on behalf of the candidate or any outside influence in any form with regard to selection will lead to disqualification.
- xx. The appointment will be terminated at any stage if any declaration/information furnished is found false or any material/fact is suppressed willfully or on any disciplinary grounds.
- xxi. The decision of the Selection Board regarding selection of the candidates will be final and no representation will be entertained in this regard.
- xxii. In case of any legal dispute, the jurisdiction of court will be Delhi/New Delhi only.
- xxiii. The list of selected candidates will be displayed on the website of Maulana Azad Medical College.
- xxiv. The selected candidates may be posted in any of the Hospital/Medical Institution in the jurisdiction of GNCTD under Health & Family Welfare Department, GNCT of Delhi.
- xxv. While candidates have been asked to give three preferences for posting in the attached Application Form, the same shall be only indicative and non-binding. It will not confer any right to posting at the place of choice. The posting of selected candidates by the Centralised Committee/Competent Authority shall be subject to administrative requirements, availability of vacancies, rank of the candidate in the selected list and ensuring fair/equitable distribution of candidates in all Hospitals/Medical Institutions. No claim or representation shall be entertained on the basis of the preference so indicated.
- xxvi. The candidate who is already in Government service should apply along with 'NOC' from the Employer.
- xxvii. If any declaration given by the candidate proves to be false or found to have willfully suppressed any material fact, he/she will be liable for removal from service or any other action as may be deemed fit.
- xxviii. The number of posts are provisional and the Centralized Committee constituted by H&FW Department, Govt. of NCT of Delhi, reserves the right to increase/decrease or cancel the post(s) without assigning any reason. A 'Panel' of suitable candidates will be formed in all the Specialties/Superspecialties in addition to the selected candidates. The validity of the 'Panel' will be for one year from the date of issue of declaration of result.
- xxix. The Competent Authority reserves the right to amend, modify or cancel this advertisement as a whole or any of its part without assigning any reason or giving notice, at any stage. Corrigendum if any, will be published only on the website of Maulana Azad medical College.
