Terms and conditions:-

- (1) The post is temporary and he/she will be appointed on officiating basis only on tenure of one (01) year extendable for a period of three years including any service rendered as Senior Resident earlier on ad-hoc/regular basis in any Institution any where in India.
- (2) The appointment can be terminated at any time by giving one month notice by either side viz the appointee or the appointing authority without assigning any reason. The appointing authority however reserves the right of terminating the services forthwith on or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the notice period.
- (3) The present appointment is for a period of one year, which is extendable for a period of three years on an annual basis, subject to the satisfactory work and conduct report from concerned Head of Department.
- (4) Private practice of any kind whatsoever is strictly prohibited.
- (5) The Services will be governed by Residency Scheme of Govt. of India & Civil Services (Temporary Rules 1978)

The appointment is further subject to:-

- a). Production of Proof of Age, Registration Certificate from D.M.C., Educational and other certificate (in original) alongwith attested photocopies of each certificate and certificate in token of belonging to SC/ST/OBC category from Govt. of NCT of Delhi.
- b). A favorable character antecedent verification report from concerned competent authority, where candidate has been residing during last five years.
- c). An undertaking to the effect that he/she has not done the Senior Residency for a period of three years, prior to this appointment.
- d). Production of Medical fitness from Appropriate Authority.
- e). If any declaration given by the candidate proves to be false or found to have willfully suppressed any material fact, he/she will be liable for removal from service or any other action as may be deemed fit.
