
NOTICE

ORDER

Whereas, in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, has issued an Order No.F.DDMA/COVID/2020/47 dated 14th April, 2020 that in view of the extension of lockdown period by Government of India; all such orders whose validity was only till midnight of 14th April, 2020, shall remain valid till midnight of 3rd May, 2020 or until further orders whichever is earlier;

And whereas vide Order No.F/02/07/2020/S.I/53 dated 15.04.2020, the undersigned issued directions to all the departments of GNCT of Delhi for strict implementation of the consolidated revised guidelines issued by MHA, Govt. of India, vide order No. 40-3/2020-DM-I(A) dated 15.04.2020 which, *inter alia*, incorporated select additional activities as relaxations w.e.f 20th April, 2020 with the caveat that UT Government may impose stricter measures as per requirement of the local areas;

And whereas, undersigned vide Order No. F.2/07/2020/S.I/64 dated 19.04.2020 has directed all the Departments to maintain "*status-quo*" with respect to strict implementation of consolidated guidelines enclosed in the order dated 15.04.2020 without any relaxation for additional activities in the NCT of Delhi till another comprehensive assessment on 27th April, 2020 or further orders, whichever is earlier;

Now Therefore after an assessment of the overall situation, in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, GNCT of Delhi, hereby issues directions to all the Departments of GNCT of Delhi to maintain "*status-quo*" with respect to strict implementation of consolidated guidelines enclosed in order of DDMA dated 15.04.2020 read with Order dated 26.04.2020, till 3rd May, 2020 or further orders, whichever is earlier, with the exception of following additional activities, which shall be allowed with effect from 28.04.2020:

- i. Clause 5 (v) - Veterinary Hospitals, dispensaries, clinics, pathology labs, sale and supply of vaccine and medicine.
- ii. Clause 5 (ix) - Movement (inter and intra State, including by air) of all medical and veterinary personnel, scientists, nurses, para-medical staff, lab technicians, mid-wives and other hospital support services, including ambulances.
- iii. Clause 8 (i) - Operation of homes for children/disabled/mentally challenged/senior citizens/destitute/women/ widows.
- iv. Clause 9 - Online teaching/distancing learning to be encouraged:
- v. Clause 14 (xi) - Services provided by self-employed persons - electrician, plumbers and repairing of water purifiers.

vi. Sub-clause (xi) and (xii) under clause 14 (included in Order dated 23.04.2020) :

- xi. Shops of educational books for students.
- xii. Shops of electric fans.
